- Per the camping requirements that apply to the youth candidates, this candidate has experienced fifteen days and nights of camping during the two-year period prior to the nomination. The fifteen days and nights include six consecutive days (including five nights) of resident camping, approved and under the auspices and standards of the Boy Scouts of America. The balance must be overnight, weekend, or other short-term camps.
- This adult leader's membership will provide a positive role model for the growth and development of the youth members of the Lodge.
- This adult will be an asset to the Order due to demonstrated skills or abilities that fulfill the purpose of the Order.
- This adult was selected based upon his/her ability to perform the requisite functions including current or prior achievement and position.
